ANALOG STATION KACV-TV CEASED OPERATIONS ON FEB. 17, 2009. THEREFORE, THIS REPORT CONCERNS ONLY KACV-DT.

Section E (Service Loss Notices)

KACV DID NOT RUN ANY SPECIAL SERVICE LOSS NOTICES FOR THE FOLLOWING REASONS. THE FCC'S PUBLIC NOTICE PREDICTED THAT 9805 OUT OF 341,975 ANALOG VIEWERS WOULD LOSE ANALOG SERVICE (2.8%). HOWEVER, KACV'S CABLE CARRIAGE ENCOMPASSED THAT "ANALOG" LOSS AREA, SO IT WAS NOT REALLY LOST. THE FCC'S ANALYSIS DID NOT TAKE INTO ACCOUNT CABLE CARRIAGE. KACV FELT THAT PROVIDING A SERVICE LOSS NOTICE UNDER THESE CIRCUMSTANCES WOULD UNNECESSARILY CONFUSE ITS ANALOG VIEWERS, WHO WERE STILL RECEIVING ANALOG SERVICE VIA CABLE, AND WOULD BE CONTRARY TO THE PUBLIC INTEREST. IF THE FCC DISAGREES WITH THIS DECISION, KACV SINCERELY APOLOGIZES FOR ITS COURSE OF ACTION, WHICH WAS WELL-INTENTIONED.
